Personal data processing policy statement pursuant to Articles 13-14 of Reg. (EU) 2016/679

Data subjects: Customers – website users.

In its capacity as the data controller of your personal data pursuant to Reg. (EU) 2016/679 (hereinafter the “GDPR”), Foroni S.p.A. hereby informs you that the said Regulation provides for the protection of data subjects in respect of the processing of personal data and that such processing be informed by the principles of lawfulness, fairness and transparency and the protection of your privacy and rights.

Your personal data will be processed in accordance with the foregoing legislative provisions and the privacy obligations set out therein. With your consent, your personal data may also be used for the following purposes:

- Provision of consultation service.

Provision of your data for the foregoing purposes is optional, and your refusal of processing will not compromise the continuation of the relationship or the appropriateness of the processing.

Processing methods. Your personal data may be processed as follows:

- creation of profiles for customers, suppliers or consumers;
- processing using automated systems.

All processing will take place in accordance with Articles 6 and 32 of the GDPR, subject to the appropriate security measures. Your data will be processed solely by personnel expressly authorised by the Data Controller, and in particular by the following categories of personnel:

- Sales Office;
- IT Office.

Dissemination. Your personal data will not be disseminated in any way.

Storage Period. Please be advised that in accordance with the principles of lawfulness, purpose limitation and data minimisation, pursuant to Art. 5 of the GDPR the storage period for your personal data is:

- no longer than needed to complete the services rendered.

Cookie management. If you have doubts or concerns regarding cookie use, you may prevent the creation and use of cookies at any time, for example by changing the privacy settings in your browser to block certain kinds of cookies.

Reg. (EU) No 2016/679: Articles 15, 16, 17, 18, 19, 20, 21 and 22 - Data subject's rights

1. The data subject is entitled to confirmation of the existence or non-existence of data concerning him or her, even if such data have yet to be recorded, to receive the data in intelligible form and to lodge a complaint with the Supervisory Authority.

2. The data subject has the right to be informed of:

- a. the origin of the personal data;
- b. the purposes and methods of processing;
- c. the logic involved in any automatic personal data processing;
- d. the identification details of the data controller, supervisors and designated representative pursuant to Article 5, paragraph 2;
- e. the parties or categories of parties to whom personal data may be disclosed or who may become aware of personal data as designated representatives in Italian territory, data supervisors or data processors.

3. The data subject has the right:

- a. to have data updated, rectified, or, where there is an interest in so doing, supplemented;
- b. to have data erased, rendered anonymous or blocked data if processed in violation of the law, including data the storage of which is not necessary for the purposes for which the data has been collected or subsequently processed;
- c. to obtain certification that the parties to whom data have been disclosed or disseminated have been informed of the operations indicated in points a) and b), including with regard to the content thereof, except where so doing proves impossible or entails the use of resources manifestly disproportionate to the right protected;
- d. to data portability.

4. The data subject has the right to object, in whole or in part:

- a. for legitimate reasons, to the processing of personal data concerning him or her, even if pertinent to the purpose for which they were collected;
- b. to the processing of the personal data regarding him or her for the purposes of the transmission of advertising or direct sales material or to conduct market research or commercial communication.
